PCAC stands for Power Cost Adjustment Clause. Mazomanie purchases its wholesale power from Alliant Energy. Power cost adjustment is a monthly charge on your bill. The amount of the PCAC is dependent on the varying cost of power purchased from Alliant Energy. A base rate of \$0.0868 per kWh is already included in the monthly energy cost. When the cost of wholesale power is above the base rate, the difference is passed on to you (a positive amount in the PC column of your bill). When the cost of wholesale power is below the base rate, the difference is passed on to you (a negative/credit amount in the PC column of your bill). The PCA amount is calculated each month by the Public Service Commission and it allows Mazomanie to keep your monthly rates consistent, rather than changing them every time the cost of energy fluctuates. The PCAC amount on this example is -0.0115/kWh.

Each month's current PCAC amount is multiplied by the current electric usage (on the above example, $-0.0115 \times 50 = \$-58.$)

- E1: ELECTRIC METER #1 USAGE (usage charge = usage (500) x .1169/kWh = \$58.45)
- EF: ELECTRIC FIXED CHARGE (\$7.50/month) (differs by rate class - see UTILITY RATES)
- PC: POWER COST ADJUSTMENT CHARGE (can be positive or negative)
- W1: WATER METER #1 USAGE (usage charge = usage (5000*) x .00265/gallon = \$13.25)
*Add 2 zeros at end of usage to get total gallons used)
- WF: WATER FIXED CHARGE (\$10.05/month) (differs by meter size) (see UTILITY RATES)
- SW: SEWER USAGE (is based on water used-any water that goes through your water meter is considered sewer usage unless you have a water only meter)
- SF: SEWER FIXED CHARGE
- GC: GARBAGE CHARGE
- PB: PUBLIC BENEFITS CHARGE (\$1.33 monthly charge)
- ST: STORMWATER (\$2.62 monthly charge)
- ET: ELECTRIC TAX (is charged six months out of the year)
- EP: ELECTRIC PENALTY*
- WP: WATER PENALTY*
- SP: SEWER PENALTY*
- TP: STORMWATER PENALTY*
